Introduction:

1. Deaf Senior Bowl will include the question-answer competition for fun and pleasure.
2. Categories of questions will relate to history, health care, economy, humor, culture and sports.
3. Those DSA members will participate as a team from a local or regional deaf Senior Citizen organization.

Objectives:

1. Cash prizes will go to those winning Senior Citizen organizations. Prizes will not go to individuals.
2. Awards will be presented after the competition:
 - 1st prize – \$2,011.00 awarded by the Chicago DSA 2011
 - 2nd prize - \$1,511.00 awarded by a provider (tentative)
 - 3rd prize - \$ 1,011.00 awarded by DSA (Ralph White Fund).
3. Each team will consist of four contestants. There must be three active players and one substitute on the team.
4. All contestants must be members of their **respective senior citizen organizations**.
5. Presidents of Senior Citizen organizations shall fill out the application (see below) and send to the Senior Bowl Co-chairs anytime before **May 30, 2011**. All presidents must verify interested participants' membership in good standing.
6. Senior citizens must be active DSA members, and 55 or older in order to participate in the Deaf Senior Bowl. In addition, they must hold their combo ticket for the 2011 DSA Conference.
7. Each team member must wear either same colored T-shirts or polo shirts.
8. Application deadline is **May 30, 2011**. We will screen all applications and then let interested organizations know in advance of the Senior Bowl.
